Covenant and Declaration of Trust

respecting the gift of £6000 by J. H. Angus Esq^r
for founding a Chair or Professorship of
Chemistry.

This Indenture

made the

Thousand eight hundred and eighty four Between John Howard

Angas of Collingrove in the Province of South Australia Esquire of the
one part and The University of Adelaide of the other part -

Whereas the said John Howard Angas is desirous of endowing a Chair
or Professorship of Chemistry in the University of Adelaide and for that
purpose has promised to contribute to the funds of the said University the
sum of Six thousand pounds in manner hereinafter mentioned and until
payment of the said sum of six thousand pounds to pay to the said
University the annual sum of Three hundred and fifty pounds And

whereas it has been agreed that the said sum of six thousand pounds
shall after payment thereof be invested and the income thereof applied in
manner hereinafter mentioned and that until payment of the said sum of
Six thousand pounds the said annual sum of three hundred and fifty
pounds shall be applied in manner also hereinafter mentioned Now this

Indenture witnesseth that in pursuance of the said agreement and in
consideration of the premises the said John Howard Angas doth hereby for
himself his heirs executors and administrators covenant with the said University
that he the said John Howard Angas his executors or administrators shall
and will on or before the first day of January one thousand eight hundred
and eighty eight pay to the said University the sum of six thousand
pounds and will in the meantime pay to the said University the annual
sum of Three hundred and fifty pounds by equal half yearly payments on
the first day of July and the first day of January in each year And it
is hereby agreed and declared that the said University shall stand
possessed of the said sum of six thousand pounds Upon trust to invest the
same as soon as conveniently may be after payment thereof in or upon the
purchase of freehold lands messuages or tenements in the province of South
Australia or upon the security of freehold lands messuages or tenements
in the said province or in or upon South Australian Government Bonds
Debentures or Securities and may from time to time vary or transpose any
such investments into or for others of any nature hereby authorized and
may also pending the negotiation and carrying into effect of any such
purchase or investment or change of investment or during any other time
when an investment of any description is being sought for deposit any -

money subject to the trusts of these presents at any joint Stock or other Bank either at interest or otherwise as may be deemed expedient And it is hereby also agreed and declared that the said annual sum of three hundred and fifty pounds or the annual income to arise from the investments representing the said sum of six thousand pounds shall be paid and applied as a fund for maintaining a Chair or Professorship of Chemistry in the said University and for defraying the expenses which may be appointed to be paid to the Professors Lecturers Examiners Officers or Servants to be appointed by the said University in connection with such Chair or Professorship of Chemistry and for defraying the expense of such scholarships prizes and exhibitions as shall be awarded for the encouragement of students who may be studying Chemistry in the said University and for providing in the library of the said University books or treatises relating to Chemistry and for discharging all necessary charges connected with the management of such Chair or Professorship of Chemistry but for no other purpose whatsoever - In witness whereof the said John Howard Angas hath hereunto set his hand and seal and the said University hath hereunto caused its common seal to be affixed the day and year first above written.


